# CALLAHAN CO. 4-H HORSE CLUB

## SHOW RULES

### Walk-Trot Rules

1. Parents may help their child in the arena during the class.
2. Exhibitors will be placed and given ribbons.
3. Exhibitors will receive a prize for hi-point within the division.
4. This division is a walk/trot only.

### Youth Rules

1. Exhibitors will show in two divisions. (12 & under, 13 & over)
2. Youth exhibitors may only enter **one** horse per class but multiple horses can be shown.
3. Exhibitors can show one mare and one gelding at halter.
4. Points are given by exhibitor not by horse. (Exhibitor doesn't have to pick a point horse.)
5. High point awards will be given in Western, English, and Timed Divisions.
6. Points will be determined by the number of exhibitors in each class.  
(Example-8 entries in the class: 1<sup>st</sup>-8, 2<sup>nd</sup>-7, 3<sup>rd</sup>-6, 4<sup>th</sup>-5, etc.)
7. A buckle will be awarded to both the high point rider over-all in County 4-H and Open Youth. Points from **ALL CLASSES** and **ALL HORSES** entered by the child will be used to determine the winner.
8. A youth exhibitor and an adult exhibitor cannot show the same horse in the same class. (Example: Child shows horse in halter then adult **can** show same horse in pleasure but **not halter.**)
9. A parent or trainer cannot give instruction during a class.

### Adult Rules

1. Exhibitors can enter **multiple** horses in **each class**.
2. There will not be a high point award for adults.
3. Ribbons will be awarded in each class.

## ASSUMPTION OF RISK AND HOLD HARMLESS AGREEMENT

In consideration for receiving permission for \_\_\_\_\_ to participate in the Callahan County 4-H Spring Horse Show, I or I/we, the parent/parents or legal guardian/guardians of \_\_\_\_\_ if participant is under the age of 18 (hereinafter referred to as "RELEASORS") hereby RELEASE, WAIVE, DISCHARGE AND CONVENANT NOT TO SUE Callahan 4H Horse Club, Texas A&M University, The Texas A&M University System, the Board of Regents, the State of Texas, their officers, servants, agents, volunteers or employees (hereinafter referred to as "RELEASEES") from any and all liability claims, demands, or injury including death, that may be sustained by the participant, or to any property belonging to them WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise while participating in such activity, or while in, or upon the premises where the activity is being conducted.

Releasors are fully aware that there are inherent risks involved in the equine activity. Such risks may include, but are limited to:

1. The tendency of an animal to behave in ways that may result in injury, harm or even death to persons on or around them.
2. The unpredictability of an animal's reaction to such things as sounds, sudden movement and unfamiliar objects, persons or animals.
3. Certain hazards such as surface and subsurface conditions.
4. Collisions and contact with other animals or objects.

Releasors hereby elect to voluntarily participate in said activity, and to enter the above named premises and engage in such activity knowing that the activity may be hazardous to the participant and its property. Releasors VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by the participant or any loss or damaged property owned by them, as a result of being engaged in such an activity. WHETHER CAUSED BY NEGLIGENCE OR RELEASEES OR OTHERWISE.

Releasors further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES from any loss, liability, damage, or costs, including court costs and attorney's fees, that may occur due to participation in said activity, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES OR OTHERWISE.

Releasors acknowledge that Callahan 4H Horse Club or other sponsors of this event do not provide any sort of insurance should injury occur.

Releasors have read the posted "Safety Consideration," in the Texas 4-H Horse Show Rules and Regulations, understand, and agree to comply with them fully.

IN SIGNING THIS RELEASE, RELEASORS ACKNOWLEDGE AND REPRESENT THAT they have read the foregoing Assumption of Risk and Hold Harmless Agreement, understand it and sign in voluntarily as their own free act and deed; no oral representations, statements, or inducements apart from the foregoing agreement have been made. Releasors execute this document for full, adequate and complete consideration fully intending to be bound by same.
